A RESOLUTION ADOPTING THE COMPREHENSIVE DEVELOPMENT PLAN 2020-2025, LOCAL DEVELOPMENT INVESTMENT PLAN, EXECUTIVE – LEGISLATIVE AGENDA (ELA) AND CAPACITY DEVELOPMENT AGENDA OF THE MUNICIPALITY OF SANTA FE, ROMBLON

WHEREAS, Section 106 of the Local Government Code of 1991 mandates each Local Government Unit to prepare a Comprehensive Multi-Sectoral Development Plan to be initiated by its local development council and approved by its Sanggunian;

WHEREAS, the Comprehensive Development Plan (CDP) is the LGU's road and progress, and it contains the vision and goals of the LGU and their strategic plans for the five development sectors namely: social, environment, economic, institution and infrastructure;

WHEREAS, the Local Development Investment Plan (LDIP) defines the three-year investment programs of the LGU while the Executive Legislative Agenda (ELA) is a shop-list priority programs and projects, with specific implementing mechanisms which the executive department should pursue in accordance which the legislative requirements necessary to support the three-year priority programs;

WHEREAS, the ELA is a practical need-based, action oriented and participatory plan that have gained support from concerned stakeholders;

WHEREAS, the identified capacity development agenda of this LGU sets the competencies and institutional arrangement which are considered required capacities for ELA implementation;
