INVITATION TO BID FOR THE

SUPPLY & DELIVERY OF MATERIALS FOR THE IMPROVEMENT/WIDENING OF ACCESS ROAD TO MUNICIPAL ECO-TOURISM PARK

The Municipal Government of Santa Fe, Romblon, through the 20% Development Fund 2021¹ intends to apply the sum of Four Hundred Eighty Thousand One Hundred Ninety Pesos (Php480,190.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the project, "Supply & Delivery of Materials for the Improvement/Widening of Access Road to Municipal Eco-Tourism Park". Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipal Government of Santa Fe, Romblon now invites bids for the project, "Supply & Delivery of Materials for the Improvement/Widening of Access Road to Municipal Eco-Tourism Park"

Delivery of the Goods/services is required thirty (30) working days after the receipt of the Notice to Proceed of the Winning Bidder. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from **Municipal Government of Santa Fe** and inspect the Bidding Documents at the address given below during **8:00 am to 5:00 pm**.

A complete set of Bidding Documents may be acquired by interested Bidders on *April 22, 2021 to May 13, 2021* from the address below and upon payment of applicable fee for the Bidding Documents in the amount of *Five Hundred Pesos (P500.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be duly received by the BAC Secretariat at the address below on or before <u>May 13, 2021 at 1:30 P.M.</u> All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on <u>May 13, 2021 at 1:30 P.M.</u> at <u>Municipal Hall, Santa Fe, Romblon</u>. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
