RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING THE AWARD OF CONTRACT TO EMQ DESIGN & CONSTRUCTION FOR THE EQUIPMENT RENTAL FOR THE IMPROVEMENT/WIDENING OF ACCESS ROAD TO MUNICIPAL ECO-TOURISM PARK

WHEREAS, the Bids and Awards Committee of the Municipality of Santa Fe declared Failure of Biddings for the Equipment Rental for the Improvement/Widening of Access Road to Municipal Eco-Tourism Park under BAC Resolution Nos. 050-B and 079 s-2021 dated May 17, 2021 and June 14, 2021, respectively;

WHEREAS, due to two-failed biddings, BAC resorted to **Negotiated Procurement under Two-Failed Biddings**;

WHEREAS, the Bids and Awards Committee invited three (3) suppliers and posted Request for Quotation for the **Equipment Rental for the Improvement/Widening of Access Road to Municipal Eco-Tourism Park** in the website of the municipality of Santa Fe, Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous place at the premises of the municipality of Santa Fe on June 18, 2021 to June 30, 2021 with an Approved Budget for the Contract (ABC) of **Three Hundred Twenty Thousand Four Hundred Pesos (P 320, 400.00)**;

WHEREAS, one (1) prospective bidder responded in the invitation for the negotiated procurement and submitted their quotation on June 30, 2021;

WHEREAS, during the preliminary examination of bids, **EMQ Construction & Supply** – San Agustin, Romblon was declared as the Single Calculated Bidder for the project listed below:


