**WHEREAS**, as per Proclamation No. 1021, the President of the Philippines extended the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 declared under Proclamation No. 929, S.2020;

**WHEREAS**, due to the increasing number of COVID-19 cases in the whole province of Romblon, diagnostic testing should be done to the close contacts, suspected and symptomatic patients and those from high risk communities;

**WHEREAS**, to be able to immediately track and screen symptomatic patients or those with exposure to COVID positive cases, there is a need to procure rapid antigen tests kits within the fastest possible time;

**WHEREAS**, in response to the current state of public health and in order to address the emergency and imminent danger in health, emergency procurement is necessary;

**WHEREAS**, the HOPE approved the recommendation of the BAC to use Negotiated Procurement – 53.2 – Emergency Cases for the said procurement thru Resolution No. 104 S. 2021;

**WHEREAS**, the end-user negotiated directly to a supplier with technical, legal and financial capability to deliver the goods;


