**RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING THE AWARD OF CONTRACT TO ALDRUG DISTRIBUTOR FOR THE PROCUREMENT OF MEDICAL, DENTAL & LABORATORY SUPPLIES**

**WHEREAS**, the Bids and Awards Committee of the Municipality of Santa Fe declared Failure of Biddings for the Procurement of Medical, Dental & Laboratory Supplies under BAC Resolution Nos. 039 and 069 s-2021 dated April 20, 2021 and May 26, 2021, respectively;

**WHEREAS**, due to two-failed biddings, BAC resorted to **Negotiated Procurement under Two-Failed Biddings**;

**WHEREAS**, the Bids and Awards Committee invited three (3) suppliers and posted Request for Quotation for the **Procurement of Medical, Dental & Laboratory Supplies** in the website of the municipality of Santa Fe, Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous place at the premises of the municipality of Santa Fe on June 18, 2021 to June 30, 2021 with an Approved Budget for the Contract (ABC) of **Forty Nine Thousand Nine Hundred Sixty Pesos (P 49, 960.00)**;

**WHEREAS**, two (2) prospective bidders responded in the invitation for the negotiated procurement and submitted their quotation on June 30, 2021;

**WHEREAS**, during the preliminary examination of bids, **Aldrug Distributor** – Lipa City, Batangas was declared as the Lowest Calculated Bidder for the project listed below:
