**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 18<sup>th</sup> day of January, 2022 between **Local Government of Santa Fe, Romblon** (hereinafter called the "Entity") represented by **ELSIE D. VISCA** – *Municipal Mayor*, with office address at Poblacion, Santa Fe, Romblon and **Equator Energy Corporation** (hereinafter called the "Contractor"), represented by **ANDY E. FALLESGON** – *Authorized Representative*, with office address at Lot 4 Blk 88, Bayani Road, AFPOVAI, Fort Bonifacio, Taguig City, 1630, Philippines.

WHEREAS, the Entity is desirous that the Contractor execute **Contract No. 2022-01-005 - Supply, Delivery, Installation and Commissioning of Municipal Wide Solar Powered Street Lights** (hereinafter called "the Works") and the Entity has accepted the Bid for **Nine Million Seven Hundred Ninety Eight Thousand Four Hundred Thirty Nine Pesos & 43/100 (Php 9, 798, 439.43)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or

the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Nine Million Seven Hundred Ninety Eight Thousand Four Hundred Thirty Nine Pesos & 43/100 (Php 9, 798, 439.43) or such other sums as may be ascertained, **EQUATOR ENERGY CORPORATION** agrees to execute and complete the works and remedy of any defects therein in accordance with his/her/its Bid.
4. The **Local Government Unit of Santa Fe, Romblon** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




