I. INTRODUCTION

The MSWDO progressively broadened its scope to encompass different welfare programs, catering to diverse demographics such as Children & Youth Welfare, Family & Community Welfare, Women and Family Welfare, Person with Disability, Older Persons and Solo Parents. Despite this expansion, the office maintained steadfast prioritization of Aid to Individual in Crisis Situation (AICS) and the Child Development Service cum Supplementary Feeding Program, with AICS securing primary allocation of funds.

The Office has to make sure that devolved programs will be given priority by the local government. These are not only for compliance but then it is also to address the present needs of the marginalized sectors which in all account must be given consideration. The office has anchored its vision after its agency's VMG, which states:

Vision:

The municipality where social welfare programs and services for the poor and disadvantaged individuals, families and communities are being generously delivered; focusing on children's welfare, investing on human resources; thereby empowering and capacitating them to improve their quality of life and cope up social challenges.

Mission:

A friendly LGU devolved office committed to support national programs and services; develop innovative strategies to ameliorate social welfare programs for the poor implementing them with honesty and sincerity to help develop their capabilities in attaining better and improved life for all.

In as much as we aim to reach this mission, we simply put this in to 5 action word such as:

M - Mobilize resources available within the community that would build partnership of all stakeholders.

S - Strengthen individuals and families and create an atmosphere of love, respect, and trust edified in the fear of God.

O - Organize and empower groups to harness potential towards a self-reliant community.

CHILD WELFARE PROGRAM

EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) PROGRAM

The ECCD program is guided by Republic Act 10410, also known as the Early Years Act of 2013. The act recognizes the importance of the first eight years of a child's life in their educational development. It also defines the rights of children to survival, development, and special protection. The program aims to provide children's preparation to formal education and enhance the roles of the parents.

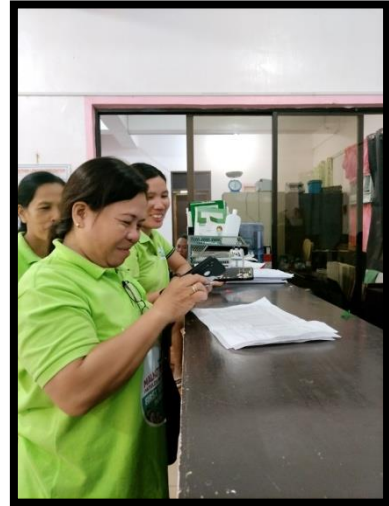
CHILD DEVELOPMENT SERVICE PROGRAM

Child Development Workers receive a monthly allowance of Php 6,000.00 from the Municipal Government. They are active partners of this office.

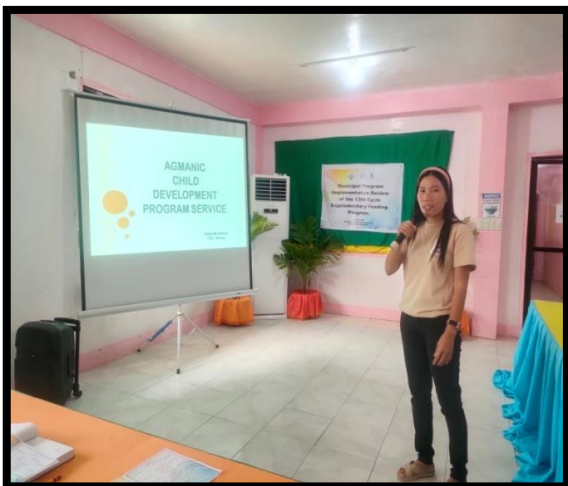

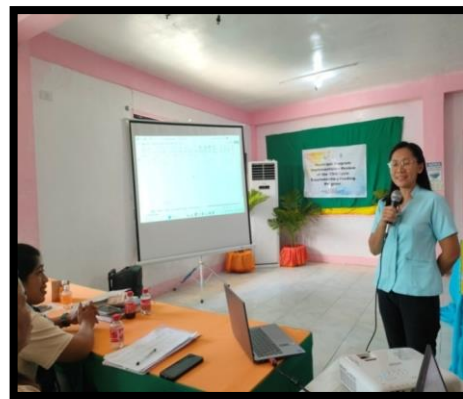

Supplementary Feeding Program (SFP) 13th Cycle

Implemented 13th Cycle Supplementary Feeding Program (SFP) to five hundred fifty (550) children of Child Development Service Program (CDSP) from **February 12, 2024 to May 24, 2024** funded by the DSWD in the amount of Php 1,386,000.00.

As part of the DSWD's contribution to the Early Childhood Care and Development Program (ECCD) of the government, the Supplementary Feeding Program (SFP) is continuously implemented by the DSWD through the MSWD Office. This program is the provision of snacks and hot meals in addition to the regular meals to children currently enrolled in CDCs.

CHILDREN IN ESPECIALLY DIFFICULT CIRCUMSTANCES (CEDC)

The increasing number of Children-at-Risk (CAR) in the municipality is very alarming. Cases of misdemeanor such as disrespect to parents and authorities, violations of school rules and regulations, violations of curfew hours, early intimate relationships to either minor and adult partners and early sexual activity. School misbehaviour such as absenteeism, cutting classes, bullying, drinking liquor, smoking, trouble making inside and outside school premises and the like. Many cases are not reported by the schools, however, some refers these cases to the MSWDO for intervention.

In the Municipality of Santa Fe, 41 reported CEDC cases in the MSWDO Office as of January-December 2024, 15 are girls and 26 boys. Most cases are Misdemeanor, Sexually Abused Children, Child Support/Child Custody, Neglect and Curfew Violators. The MSWDO give intervention to clients such as:

1. Counselling Sessions
2. Dialogue for Children together with parents/guardian
3. Provided financial assistance
4. Facilitated legal assistance
5. Facilitated agreement for child custody/child support
6. Referral for protective custody/institution for children
7. Home and Center Visit to abused clients




Home and center visitation to abused children. One case was referred to Ruel Foundation Incorporated for temporary shelter and protective custody.




Comprehensive Local Juvenile Intervention Program (CLJIP)

The MSWD Office conducted a 1-day-orientation workshop for the Comprehensive Local Juvenile Intervention Plan (CLJIP) together with the Municipal Mayor, 11 Punong Barangay, 11 VAW Desk Officers, SK Chairpersons, MLGOO, 2 MPDC Staff, and 7 MSWDO Staff. This orientation workshop aims to protect and promote the rights and welfare of the Child-at-Risk (CAR) and Children in Conflict with the Law (CICL) and prevent CAR from committing crimes and ensure that CICL are rehabilitated and reintegrated into their families and communities.

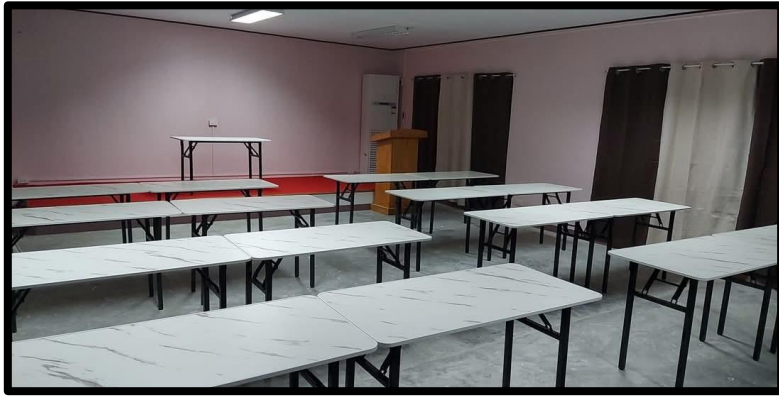


SANTA FE WOMEN EMPOWERMENT AND LIVELIHOOD CENTER (SFWELC)

The establishment of Santa Fe Women Empowerment and Livelihood Center (SFWELC) has rooted from the aspiration of a local women leader who also was a member of the local council in 2018. The realization of the whole building was funded by the DIWA Partylist in the amount of Two Million Pesos (Php 2,000,000.00) in January 2019. However, it only become fully functional in 2024 after the Local Government Unit (LGU) provided funds for equipping.

The allocations was part of the LGU's 2024 Gender and Development (GAD) Funds amounting to Php 700,000.00 . The center is now providing convenient and comfortable venue for empowerment and livelihood skills training not only for women but also to other sectors of the municipality. Furthermore, the SFWELC has four (4) electric sewing machines as the KALIPI Women Livelihood Project received from the Provincial Government.





18-Day Campaign to End Violence Against Women (VAW) November 25, 2024

Santa Fe Municipal Police Station in partnership with the MSWD Office conducted a motorcade kick-off activity to observe the 2024 18-day campaign to end VAW from November 25 to December 12, 2024 with a theme: “VAW Bigyang Wakas, Ngayon na and Oras! “ and participated in the regular flag-raising of LGU-Santa together with SB Maria Imelda F. 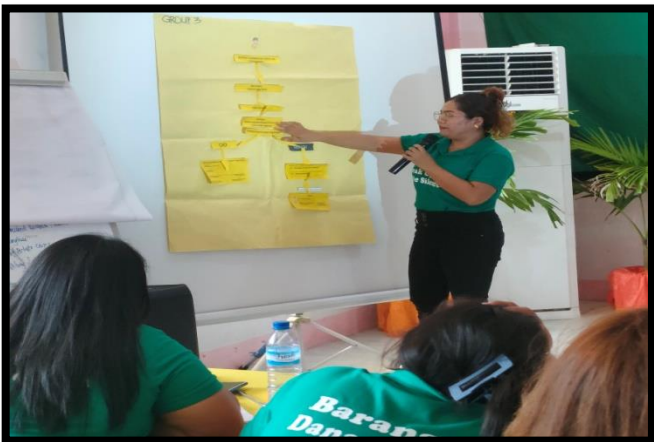

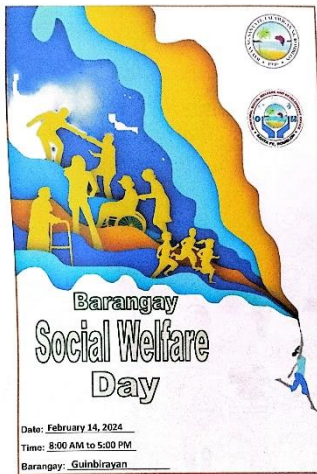

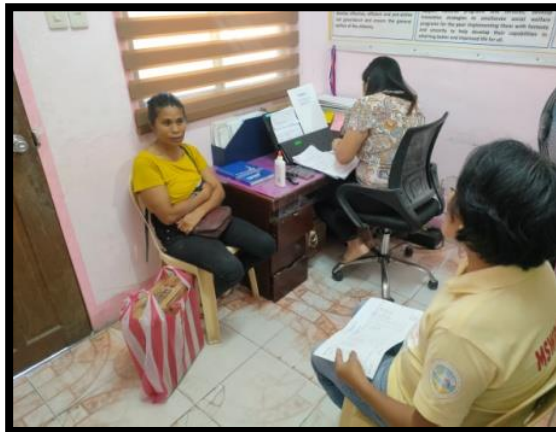

DISASTER WELFARE PROGRAM

- Seventeen (17) Child Development Centers (CDCs) facilitated and conducted Food-for-Work program to parents of children enrolled at CDCs last July 4-8, 2024. 11 Barangays benefited the project, 10 Barangays with 45 beneficiaries and 1 Barangay with 50 beneficiaries. Two boxes of Family Food Packs were extended to each beneficiary in exchange of the work done for 5 days.
- This project targeted families living below the poverty line, individuals affected by disaster, residents of geographically isolated and disadvantaged areas, and those who are unemployed.
- The activities focused on the following disaster mitigation and environment related activities:
 - a. Declogging of major drainage system, rivers and creeks
 - b. Clearing of roads
 - c. Maintenance of CDCs and gardening. Gardening is in support to Supplementary Feeding Program.

Community Based Rehabilitation Program for Children with Disability

Para- Teacher provided services to targeted beneficiaries in their homes.

Para-Teacher ensures that children with disability are able to maximize their physical and mental abilities, to access regular services and opportunities, and to become active contributors to the community and society at large. E-TAWAG Program's focus is to teach children on the daily living skills such as grooming, dressing toileting, tooth brushing and bathing, and eating. Para-Teacher's concern is the intellectual development of these children.

Currently, the Para-Teacher has enrollees of 16 CWD comprising with 11 male and 6 female with age ranging from 4 to 18 years old.

Program Activities

Last February 28 and March 15, 2024, Pantawid Staff conducted a Focus Group Discussion (FGD) to the perennial non-compliant children in education, this activity give awareness to the NC children about the importance of education that education has many benefits and has positive impact in everyone's lives and instil to their mind that the better educated we are, the more able we will be to help out our families and communities.

Most reasons captured and shared by the children are learning difficulties and not be able to perform their best despite of the best educators resulting to lose their interest in studies.

Pantawid Santa Fe facilitated the conduct of pay out on September 10, 2024. Beneficiaries received grants for P4 with a total amount of Php 6,325,400.00.



The MOO staff conducted MIAC last September 13, 2024 attended by partner stakeholders in the program, held at SB Session hall, Poblacion Santa Fe.



The SWDI administration to priority households was conducted started on August 12- September 19, 2024 to target beneficiaries and is still ongoing for the 11 monitored barangay in Santa Fe.



SUSTAINABLE LIVELIHOOD PROGRAM (SLP)

The Sustainable Livelihood Program (SLP) in Santa Fe, Romblon, is actively engaged in monitoring of 125 official grantees. This initiative specifically involves 50 individuals supported by Mayor Visca and 75 individuals backed by the Vice Governor as of July 2024.

On October 11, 2024, the MPDO attended the third quarter SLP provincial meeting with partners and stakeholders. The PDOs prepared and submitted CCEF on October 28, 2024. Additionally, the program is overseeing the implementation of regular SLP projects managed by three Sustainable Livelihood Program Associations (SLPAs) and conducted in the 2nd monitoring in November based in Canyayo, Agmanic, and Tabugon. These associations collectively benefit 81 individuals under the regular funding structure.

The SLP efforts also include close monitoring of partner beneficiaries. This is particularly focused on the execution of regular SLP projects in the Bong Go area, which supports 67 beneficiaries from the 2023 cohort. Also the MPDO focuses on completing the mainstreaming exit plan and encompass beneficiaries from the earlier years of 2019, 2020, and 2021. This comprehensive monitoring serves as the fourth round of evaluation for these initiatives, ensuring that all aspects of the program are effectively delivered and that beneficiaries receive the support they need to enhance their livelihoods.

PERSON WITH DISABILITY (PWD) PROGRAM

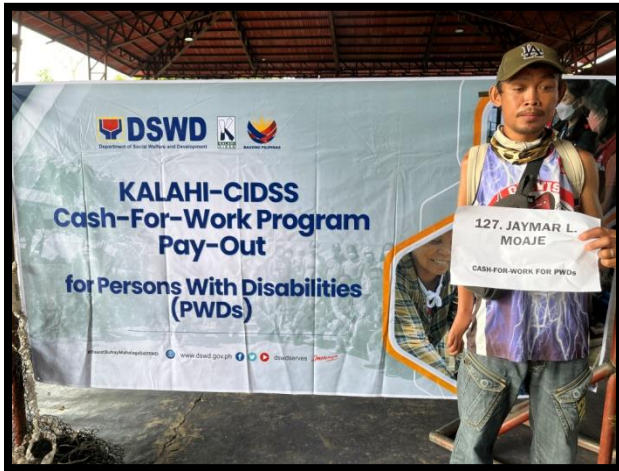
